

Journal Publishing Agreement

This agreement is made between the authors (the “Authors”) identified below and the **International Journal of Interdisciplinary Medicine and Applied Sciences (IJIMAS)**, published by the **London Medical and Applied Sciences School (LOMNAS)** (the “Publisher”).
